BEE WELL kept touch with the leaders, bid before the final hurdle, went three-wide in the far turn to outkick rivals in the stretch for the win. STARFORCE stalked the pace, challenged before the final hurdle, but could not hold back BEE WELL in the stretch. ORDERS ANTHEM (IRE) went to the early lead to set the pace, entered the stretch in the lead, and was outfinished. DANTE'S FIRE raced midpack, rallied after the final hurdle but could not gain position. ANOINT raced out the back and was no factor. ATTRAYANT trailed and was never a threat.
