GOOD SEPERATION off slow, bumped both sides, rallied. SEND THE HERO pushed in break, bid, up for place. USE OF FORCE away alertly, faltered late. THE BLACK BEAST bore in, bumped foes. COWBOYS REVOLVER bore out, bumped, lost path. SUNFIRE EAGLE even effort. PATRIOT EYE AM bore out, faded. THE TOMAHAWK no menace. DEMENTED pinballed, steadied. MR STREAKIN EAGLE broke slow, no factor. FOLLOWING THE RACE, THERE WAS A STEWARDS INQUIRY INVOLVING THE BLACK BEAST AND PATRIOT EYE AM, FOR INTERFENCE JUST AFTER THE BREAK AND A JOCKEY'S CLAIM OF FOUL FROM THE RIDER OF COWBOYS REVOLVER ON THE RIDER OF SEND THE HERO. AFTER REVIEWING THE FILMS, THE JOCKEY'S CLAIM OF FOUL WAS DISALLOWED, BUT STEWARD'S INQUIRY RESULTED IN A DOUBLE DISQUALIFICATION OF THE BLACK BEAST FROM FOURTH TO EIGHT AND PATRIOT EYE AM FROM SEVENTH TO NINTH.
