SENROR BONES bore in sharply, mid stretch, dueled lead, driving. SILKY GRAY SILK broke sharp, bore out mid stretch, dueld lead. HOT LIL SEIS bumped both sides, held show. IAN LIGHTFOOT squeezed back, steadied, lost path. ALEXS STEAM ENGINE even effort. UNWARE never fired. HOCKALISHOUS pushed in, bumped foe. VALIANT WAGON dropped back. A S TEMPTING SEIS off slow, no threat. RNR UNO always outrun. FOLLOWING THE RACE, THERE WAS A STEWARDS INQUIRY REGARDING SENOR BONES AND SILKY GRAY SILK. ALSO, THE TRAINER OF HOT LIL SEIS CLAIMED FOUL AGAINST SENOR BONES AND THE TRAINER OF IAN LIGHTFOOT CLAIMED FOUL AGAINST SILKY GRAY SILK. AFTER REVIEWING THE FILMS, SENOR BONES WAS DISQUALIFIED FROM FIRST AND PLACED SIXTH AND SILKY GRAY SILK WAS DISQUALIFIED FROM SECOND AND PLACED SEVENTH.
