TRIALS - Quarter Horse

FOR TWO YEAR OLDS THAT WERE NOMINATED AND REMAIN ELIGIBLE FOR THE 2026 RAINBOW QUARTER HORSE FUTURITY. Weight: 124 lbs. All horses must enter for the trials on Friday June 19, 2026 by 10:30 A. M. and pay the \$1,200 entry fee if they are to run in the trials. Late nominations of \$30,000 (includes all fees) will be accepted at time of entry into the trials. Those who want to remain eligible for the 2027 Rainbow Derby, but elect not to run in the 2026 Rainbow Futurity time trials may do so if they are still eligible at the time of entry into the trials, by paying the \$1,200 entry fee into the Rainbow Futurity time trials. The five fastest times from the trials for each day will qualify for the finals. There will be no "Also Eligible List" for the finals. NOTE: All races this day will be trials, first post time may change due to the number of races. 400 Yards.
