SOLO ME was never far back in an outside trip, closed steadily, wore down his rivals to get up late and won going away. SHINY SHORES led early, pressed the pace, bid willingly, got a head in front past the eighth pole and was outclosed to finish second best. GIMME A WHO was slow early, swung wide entering the stretch and finished well to get up for show. FIGHT MONEY bumped at the start, raced inside to the turn, offered a mild bid only and improved position. FINAL TRIAL pressed the pace, bid and came up empty. BOONE was never far back, checked entering the turn, dropped back and gave way. NO MASK REQUIRED lost his footing and came in at the start, was in tight entering the turn and lacked a bid. W F AMERICAN CAT moved up inside to set a pressured pace to mid stretch and stopped. SWEET CHAOS pressed the pace between horses early, dropped inside and lacked a stretch response. ICEE MOVE was not a factor. FIRE UP LUTE bumped, was steadied and pinched back at the start, swung wide leaving the turn and lacked a bid. This race had a

timing discrepancy or malfunction, and it was re-timed using video technology to obtain the most accurate final time available. Internal fractions have been removed and are not available.
