FIREBALL AR steadied early, mild late run. CB CARTELSDASH forced in sharply early, even effort. HES MIGHTY PERFECT off slow, never fired. NOGAL taken up sharply, no shot. FOLLOWING THE RACE, THERE WAS A STEWARD'S INQUIRY REGARDING CB CARTELSDASH; THE JOCKEY OF NOGAL, CLAIMED FOUL AGAINST THE RIDERS OF A CLASSY RULER AND CB CARTELDASH ; THE RIDER OF CB CARTELSDASH CLAIMED FOUL AGAINST THE RIDER OF A CLASSY RULER AND THE TRAINER OF CB CARTELSDASH CLAIMED FOUL AGAINST FIREBALL AR. AFTER REVIEWING THE FILMS, A CLASSY RULER WAS DISQUALIFIED AND PLACED LAST FOR INTERFERENCE AFTER THE BREAK. ALL OTHER CLAIMS WERE DISALLOWED.
