All horses must enter for the trials on Friday July 31, 2026 by 10:30 AM and pay \$1200 entry fee., if they are to run in the trials. Late nominations of \$50,000 (includes all fees) will be accepted at time of entry into the trials. Those who want to remain eligible for the 2027 ALL AMERICAN DERBY , but elect not to run in the 2026 ALL AMERICAN FUTURITY TRIALS may do so , if they are still eligible at time of entry into the trials, by paying \$1200 entry fee. The five fastest times from the trials each day will qualify for the finals. There will be no "also eligible" list NOTE: All races this day will be trials, first post time may change due to the number of races.
