MCKINZIE STREET set the pace racing slightly removed from the rail. opened a clear lead nearing the quarter pole and maintained a safe advatnage. FIRE BREATHER prompted MCKINZIE STREET from along the outside, was unable to reach that one but finished well in a steady effort. FIFTY CINCO was unhurried, came three-wide into the stretch and rallied late. ALBERTUS was allowed to settled, came four-wide into the stretch but lacked a rally. UNDER OATH saved ground chasing MCKINZIE STREET to the stretch and weakened slightly late. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate final time available.
