## Footnotes | View Glossary Of Terms

BLAZING TO GOLD vied for the lead in the four path, led between foes in the three path midway around the turn, dug in while dueling with an outer rival down the lane, was headed by that rival passing the eighth pole, but fought back to hold on. RAPID EXPANSION stalked in the five path, bid in the four path midway around the turn, ran on to sustain that bid and headed an inner rival passing the eighth pole, but was repelled by that foe late. RAINBOW CREST stumbled and bumped with an inner foe at the start, tracked in the three path, bid around the turn, but flattened down the lane. CHECKSFORCHARLIE bumped with an outer foe at the start, trailed in the three path, was driven around the turn, floated out to the six path at the top of the stretch, but made no closing bid. STORMIN ATTILA pressed in the two path early but yielded around the turn. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate time.
