AUTUMN'S TURN was urged along towards the rear, angled from the two path to the five path on the turn, rallied outside into upper stretch, closed well to get the lead in the final sixteenth and narrowly prevailed under strong urging. A. P. SLINGSHOT reared at the start and was off slow, raced well back in the field on the outside, moved in leaving the backstretch, dropped from the two path to the inside early on the turn, shifted to the four path while gaining late on that bend, rallied to the lead in upper stretch, led into the final sixteenth but was caught while clear for the place. WILL OF A WOMANNE bumped soundly with a rival at the start then was hustled, was well placed just off the pace, made a bid at the seven-sixteenths pole, took the lead in the three path with three furlongs to run, lost the advantage in upper stretch and weakened while well clear for the show. FIRE AGATE showed speed then took the lead inside the seven-eighths pole, vied two path to the inside on the turn, lost the lead with three furlongs to run and tired. GRACIE GIRL showed speed and led early, lost the advantage inside the seven-eighths pole then tracked the pace, came up empty while dropping from four path to the two path early on the turn and retreated. TIZALLMINE bumped soundly with an opponent at the start, was urged along near the back, saved ground on the turn and was no factor.
