TENACIOUS CHILD showed speed and set the pace with a clear advantage, dropped from the two path to the inside very early on the turn, responded well when put to a drive in upper stretch and drew off while kept to the task. GRIT N GLITTER was urged along at the rear, saved ground on the turn and improved for the place. SHE'S BANKABLE was hustled from the gate, angled in early then chased the pace on the outside, moved from the three path to the two path very early on the turn, pursued the winner under a drive into upper stretch and weakened while clear for the show. BOILING POINT broke out then was corrected by the rider, was well placed just off the pace, chased late on the backstretch, dropped back early on the turn, saved ground on that bend and came up empty. GAME AND BLUE broke out then bumped with a rival and was taken up, spotted the front a few lengths, was ridden along towards the rear, dropped from the three path to the two path early on the turn, made her way to the inside around the three-eighths pole then moved back to the two path and failed to threaten. FAIRY GODMOTHER was urged along on the outside, traveled around the turn in the four path and failed to respond. ISHKABIBBLE tossed her head at the start and was taken up, spotted the front a few lengths, was urged along near the back, rounded the turn in the five path, turned into upper stretch in the seven path and was no factor. FLEE settled off the early pace, climbed significantly outside the five-eighths pole then dropped back, climbed a bit early on the turn, raced in the three path on that bend, moved to the four path nearing the quarter-pole, came out to the six path into upper stretch and also failed to respond. MY GIRL AUBREE bumped with a rival at the start, was taken in hand briefly when a foe crossed in front early, raced under urging from that juncture, moved closer late on the backstretch, chased in the five then four path on the turn and faltered.
