REQUISITION set the pace and drew off in the drive under steady urging. LORD WIMBORNE (IRE) raced close to the pace in an outside trip, lacked a late response and was no match for the winner. THIRSTY BABY was unhurried early, put in a steady effort and was along for show. HIGH PRINCE trailed the field and passed a tiring rival. MCCLUSKY led early, showed speed to the turn, weakened, faded through the stretch and was transported off the track via an equine ambulance.
