WHEELER DEALER stalked the pace from three wide to the top of the stretch then made a late run and battled with HEY NOW and bumped with that one near the eighth pole but kept on to prevail. HEY NOW trailed the field to the top of the stretch while racing widest then made a rally to battle down the stretch outside of WHEELER DEALER and bumped with that one near the eighth pole, kept on but was outkicked and proved second best. UNUSUAL WIN pressed the pace from two wide to the turn then matched strides between FERRARI RED and RACER REX to the quarter pole then kept on inside of RACER REX while taking a brief narrow lead to the eighth pole and was overtaken in deep stretch and held the show. RACER REX raced off the pace from four wide before matching strides outside of FERRARI RED and UNUSUAL WIN to the quarter pole and kept on outside of UNUSUAL WIN to the eighth pole before faltering. FERRARI RED showed good early speed to the turn then matched strides inside of UNUSUAL WIN and RACER REX to the quarter pole before giving way. THE JOCKEY OF HEY NOW CLAIMED FOUL AGAINT WHEELER DEALER FOR ALLEGED INTERFERENCE IN THE STRETCH RUN, AFTER A STEWARDS REVIEW THE CLAIM OF FOUL WAS DISALLOWED AND NO ACTION WAS TAKEN.
