GUTFIELD dueled two wide and drew off under a drive. CROWN PROSECUTOR raced off the pace two wide, continued on the left lead in the lane and rallied inside of foes to gain the place late. NO SOY BORRACHO stalked the pace three wide and was one-paced through the lane to maintain the show. IT'S LATER BURT chased the pace four wide and lacked the needed rally. DINERO DE LA CASA dueled inside of the winner and tired in the drive. CHOCOLATE WASTED checked soon after the start, raced two wide and never threatened. GRACE'S HANK trailed inside.
