PERCEPTIVE raced near the back from three wide to the top of the stretch and when asked drove past the leader and drew clear late. SARAH'S COURT raced near the back while saving ground to the top of the stretch then tipped out and made a late run but was no match for the winner. LAZY DAYS tracked the leaders from off the rail before moving up to engaged the leader near the quarter pole and took the lead going into the stretch but was overtaken near the sixteenth pole and stayed on to be a clear third. GRACIE'S A TIGER went to a clear lead to set the pace to midway through the turn before being collared near the quarter pole and tired. MORE TROUBLE stalked the pace for a quarter before retreating.
