RIGHT OF REFUSAL was allowed to settle in the middle of the pack from three wide through the turn then made a late rally to run down the leader to be up in the final yards. DODGEBALL sped away to a clear lead before being headed midway through the turn then drew clear going into the stretch but was denied in the final yards. BROWN LIAISON raced off the pace from between horses through the turn then made a late kick to be up for the show. GLOBAL ALLURE chased the pace before moving up to engage the leader midway through the turn but lacked the late response and weakened. RUNTOLIVE trailed the field and passed tired one in the stretch. WARREN'S WILD RIDE raced near the back down the backstretch then made a rail bid on the turn but faltered.
