MISS YOU NO MORE settled in the middle of the pack from off the rail through the turn then moved between horses in upper stretch to run down the lead and drive past that one to prevail. LADY ADMIRAL pressed the pace down the backstretch then moved up to engage the leader near the three furlong marker and fought gamely before being outfinished in the final jumps. MS BUMBLEBEE raced off the pace down the backstretch then move up the rail to take the lead midway through the turn but tired in the final sixteenth and held the show. JANA SUE stalked the pace from four wide through the turn but lacked the late response needed. DELPHINE trailed the field while saving ground but was not a factor. BEYOND THE LAW went to the early pressured lead before being overtaken near the three furlong marker then vied for the lead to the top of the stretch and gave way.
