ARIZONA MOON BEAM stalked the pace for three-quarters, ralied five wide down the lane, drifted in under right hand urging inside the final sixteenth to bump with the runner-up late and prevailed in the drive. KALAHARI KING pressed the pace to the top of the lane, vied for the lead down the stretch from between rivals, was bumped by the winner as the gap narrowed due to inside rival bearing out and was denied in the final strides. DESERT MOON set a pressured pace through tepid fractions to the head of the stretch, dueled the length of the lane drifting out under left handed encouragement causing the runner-up to be put in tight and carried out into the winner, and ran-on willingly while outkicked late in a game try. THREE DRINKS was not a factor. THE RIDER OF THE RUNNER-UP CLAIMED INTERFERENCE BY THE WINNER IN THE STRETCH RUN, UPON REVEIW THE STEWARDS MADE NO CHANGE.
