## Footnotes | View Glossary Of Terms

WATER TESTER set the pace in the two path, waited confidently while inching away around the turn, floated out to the four path while being roused at the top of the lane, and drew clear. WORK ORDER prompted the pace inside, tipped out to the three path while coming under a ride midway around the turn, floated out to the six path at the top of the stretch, and chased on to be second best. RUNNIN BUFFALO chased in the three path but weakened in the stretch.
