MOON SHINE TIME took command on the inside shortly after the start and never looked back. BRANNIGAN raced in the middle of the pack, bid on the two path at the final quarter to stalk the pace in the stretch but could not close. FLEET OF HOOF settled back to trail early, improved position along the inside of the turn, up for show in the stretch. EURO TRACKING stalked the pace four wide, weakened in the stretch. AWESOME FAMILY settled off the pace, trailed through the turn, passed tired foe in the stretch. GRAN CHICO rated three wide behind the pace, retreated in the stretch. RIGHT TO SUE pressed the pace between foes, slowly retreated starting at the three eighths.
