SHE'S SO TRUE settled off the pace, angled towards the inside of the stretch to be up for show. GLITTERS ANDIE took the early lead to set a pressured pace, gave way at the quarter and retreated. DYIN A THIRST trailed for most, passed tired foe in the stretch. STAR STUDDED BANNA opted foe the inside of the middle of the pack, began slowly retreating starting at the three eighths, eased across. FINISHING MARGIN BETWEEN DYIN A THIRST AND STAR STUDDED BANNA WAS ESTIMATED DUE TO A CAMERA MALFUNCTION.
