GUCCI BOY tracked inside, was ridden around the turn, angled out to the four path passing the eighth pole, and stayed on to draw past an inner foe late. MAIUS set the pace in the three path, was roused from the two path midway around the turn, kept on while on the left lead in the three path down the stretch, but got caught by an outer foe in the final strides. WARRENS WORLD stalked in the four path, was ridden in the three path around the turn, flattened in the four path down the lane, but held show. HUSKER BUTCH rated in the five path, floated out to the seven path entering the stretch, and finished evenly. CHERRY RIVER chased from the three path but faded in the five path down the lane. MY CRAZY NEIGHBOR raced off the pace in the three path and made no closing bid. DRIVEHAPPY trailed along the inside and never threatened. SCRATCHY APACHE was wellback in the five path and never menaced.
