## Footnotes | View Glossary Of Terms

DIAMANTE ELEGANTE bumped with an outer foe at the start, showed the way along the inside, was roused midway around the turn, and drew clear. RUNNIN ON PROMISES broke out, pressed the winner from the two path, was driven around the turn, could not keep up with that foe down the lane, but held place. JOYFUL JOSEPHINE chased in the two path, was ridden in the four path around the turn, and kept on while on the left lead down the stretch to get up for show. SO THRILLING rated inside, was driven around the turn, but lacked a final bid. POPS REWARD stalked in the four path but faded. GINGER IN CHARGE bumped with an inner foe at the start, tracked in the three path early but weakened.
