TERRY'S SERVICE pressed the pace between rivals, bid for command in the final sixteenth to be the first home. SHOOTIN' DICE pressed the pace three wide, had no closing bid but was able to secure the place award. GUTFIELD set a pressured pace from the inside, yielded the lead in the final sixteenths and weakened to third. NOBLE LAKER raced far off the pace, made no impact, eased across. GRACE'S HANK was the distant trailer, eased across. TIMING ERROR CAUSED THE QUARTER MILE TIME TO BE INCORRECT.
