YOU VEE CEE dueled between horses, gave way late turn, kept coming to take over late. KATE'S PRINCESS dueled inside, opened up stretch, gave best, couldn't hold. PLEASE THE COURT stalked five-wide, rallied widest. PROMISE CODE stalked duel off rail, finished evenly. BECKETT'S BEST, back early, advanced mildly inside. OREGON COUNTY moved out widest early, remained six-wide, lacked rally. SHIP BOSS dueled three-wide early, forced issue turn, gave way late turn. RICK'S DANCER pressed inside early, stalked duel inside turn, faded.
