LADY DELILAH pressed the pace two wide and made a three wide bid leaving the turn to be clear by the furlong marker and then lasted late to prove best under a drive. BOUNDING ALONG hit the gate and was off a length or two slow, reserved early and advanced five to four wide on the turn, came five wide off the turn and closed well to just miss late. KHALI'S STORM was away alertly to set a pressured pace by the five eighths marker and on the turn and then relented the lead leaving the quarter pole and was empty in the final furlong while saving the show award. GRIT N GLITTER was allowed to settle early, raced two to four wide on the turn and came five wide into the lane and had a belated rally. SUCCESSFUL AGENDA chased the early pace and saved ground on the turn and weakened. I REST MY CASE stalked the early pace on the outside and then chased the pace four wide on the turn but stopped.
