HOME PAGE prompted the pace in the three path, was driven around the far turn, bid passing the quarter, stayed on to sustain that bid down the lane, and drew ahead of the inner pacesetter in the final sixteenth. THE FORM had an awkward start, set the pace while rated between foes in the two path, held command entering the far turn, came under pressure while just off the rail midway around the far turn, fought on along the inside into the lane, but yielded to the outer winner around the sixteenth to place. NOBLE COURT laid up close inside, was ridden from the rail into the far turn, got put in tight midway around the far turn, angled outwards passing the quarter, but flattened in the four path down the lane.
