JUDGE HERNANDEZ dueled between foes in the two path early, held command while in hand along the inside passing the three-eighths pole, waited around the turn, received a right handed cue at the top of the lane, and kicked away. SAKI BOMB trailed in the two path, was coaxed along around the turn, floated out to the six path at the top of the stretch, and kept on to get up for place. STATE PARK chased in the three path, was nibbled along around the turn, but finished on one pace from the four path while on the left lead for show. DAVE DID IT vied for the lead inside, was cued in the two path midway around the turn, but weakened.
