ASK AMANDA raced in midpack from the three path, was roused in the four path midway around the far turn, rallied outside of rivals from the five path down the lane, and drew ahead of an inner rival in the final strides. SILENT SKY tracked inside, was roused from the rail midway around the far turn, got stymied behind the pacesetter passing the quarter, slipped thru a narrow opening along the rail to bid at the top of the lane, drew ahead to hold command passing the sixteenth pole, but got nailed by a late charging outer rival at the wire. BLOSSOMING set the pace in the two path, was roused from just off the rail passing the quarter, dug in down the lane, but yielded between foes in the final sixteenth. RETAIL THERAPY was wellback inside, ridden in the two path around the far turn, angled out to the six path in upper stretch, and ran on. SWIGERT was unhurried in the three path early, coaxed along around the far turn, and finished evenly in the four path down the lane. ALL ABOUT ME prompted the pace in the two path, was ridden around the far turn, fought on in the three path down the lane, but flattened around the sixteenth. MS TEMPTATION trailed in the two path, was ridden around the far turn, fanned out to the seven path in upper stretch, and made no impact. CACHACEIRA raced up close in the three path but faded in the stretch. GRACELEADSUSHOME rated in the two path but never threatened.
