CHANTICLEER showed the way, waited in the two path around the turn, came under a ride entering the stretch, kicked on while drifting out the five path passing the furlong grounds, then angled back in around the sixteenth impeding an inner rival in the closing stages, and held on. DAUNTED raced up close in the four path, was cued in the three path midway around the turn, ran on from the four path into the stretch, bid from the three path in the final sixteenth, but had to steady late. MAX N' LOU tracked inside, was roused from the rail midway around the turn, and kept on from the three path down the lane while on the left lead for show. LOW STANDARDS stalked, was ridden in the three path around the turn, swung from the five path into the stretch, and finished evenly. MOORE GOLD raced in range in the three path, was cued in the two path midway around the turn, but finished on one pace. TATTOO had a slow start, rated in the three path but made no closing bid. WHISKY RESERVE raced off the pace in the four path and made no impact. LUCKCREST had a slow start, was wellback inside and never menaced. AFTER A STEWARDS INQUIRY AS WELL AS AN OBJECTION BY THE RIDER OF DAUNTED AGAINST THE RIDER OF CHANTICLEER FOR INTERFERENCE AROUND THE FINAL SIXTEENTH, CHANTICLEER WAS DISQUALIFIED FROM FIRST AND PLACED SECOND FOR DRIFTING INTO THE PATH OF DAUNTED JUST AFTER THE SIXTEENTH POLE IMPEDING HIM OF A FAIR CHANCE AT THE WIN.
