BOB MO pressed the pace in the two path, bid under a ride midway around the turn, took the lead from the three path turning into the lane, and forged clear in the final furlong. PULGARCITO set the pace inside, was cued midway around the turn, fought on while losing the lead at the top of the stretch, faded in the final furlong, but was clearly second best. TIEMPOS BUENOS rated inside, was ridden around the turn, had no closing kick, but was along for show. PERIPOLI stalked in the three path, was coaxed passing the three-eighths pole, but flattened in the five path down the stretch. GREATDAYFORHOCKEY chased in the three path, was driven around the turn, but made no closing bid in the five path down the lane. JUDGE HERNANDEZ steadied at the start, trailed in the four path, was ridden around the turn, and did not threaten.
