CALTHA pressed the pace in the two path, bid passing the three-eighths pole, was roused in the two path passing the quarter, held command in the three path entering the final furlong, and drew away latee. GENERAL GINNY tracked in the three path, ranged up under a ride passing the quarter, and kicked on to chase home the winner for place. JOIA RARA set the pace inside, was ridden around the turn, fought on in upper stretch, but faded in the final furlong. SONHO DE VERAO chased inside, was ridden in the two path around the turn, but made no impact from the three path down the stretch. DR. BELLA trailed in the three path, was coaxed along around the turn, but did not factor from the five path down the lane.
