ORGANIZED stalked the pace, vied two deep between through the stretch run, drifted a bit through the stretch run and prevailed under all out pressure. S J B EXPRESS bumped at the start, settled to raced in hand early, vied three wide from the outside near the quarter pole, forced out through the stretch racing from the outside, jockey of S J B Express claimed objection against Organized for interference through the stretch run along with a stewards inquiry and stewards deemed no change. SIERRA POWER showed good early speed along the inside, angled out just past the three sixteenths pole to raced off the inside and weakened. MYSTANDARDS bumped soundly at the start, trailed early on, ridden three wide near the quarter pole and had no response. WILDERZAR prompt the early leader from the outside and faded. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate time.
