ONE FOR MY BROTHER took charge shortly after the start, faced outer pressure from HEAVY HITTER entering the stretch, battled that foe until edging clear late. HEAVY HITTER tracked the pace four wide in the early stages, ranged up through the turn to contest ONE FOR MY BROTHER in the stretch but was out-finished. SIR THOMAS TEAL was rated along the inside, backed off in the turn, swung into the four path of the stretch to get up for third. FIRE WIRE trailed for most, passed tired foe in the stretch. HE'S SIDE EYED broke sharply but opted to chase the pace between runners, tired down the stretch. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate times.
