GAME POINT tracked the leaders off of the inside, launched a bold bid leaving the second turn, shifted out three wide entering the stretch, drifted in slightly in the drive, reeled in KING OF KENTUCKY and shook clear late. KING OF KENTUCKY established command at once, tucked and set the pace along the inside, turned back the bid of OUR SLICEOF HEAVEN leaving the second turn, fought on through a prolonged drive but was unable to go on with the winner. OUR SLICEOF HEAVEN prompted the pace outside, moved up to engage the leader nearing the quarter pole, weakened entering the stretch, drifted out nearing the furlong marker when the winner crossed over and faded. OCEAN POINTE was unhurried into stride, moved up some through the second turn, came three wide, steadied off heels when OUR SLICEOF HEAVEN came out near the furlong marker and failed to seriously threaten. The jockey of OCEAN POINTE lodged an objection for alleged interference against OUR SLICEOF HEAVEN inside the furlong marker, following the review the Stewards made no change to the order of finish. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate time.
