## Footnotes | View Glossary Of Terms

SUCCESSION GOLD reserved near the rear of the field through the first turn, commneced an early bid at the half mile pole, swept up six wide on the turn with an early move to take command and drew clear convincingly. GUCCI MAN tracked the leader from between rivals into the far turn, was put in tight quarters when TIE BREAKER LENNIE angled in on the bend further crowding rival to the inside, took in hand briefly checking to avoid that inside rival, rallied at the quarter pole re-gaining momentum and made up ground with a late bid in the lane. TIE BREAKER LENNIE tracked the pace down the backside, moved to a striking position into the turn, angled in a path when the winner swept up to his outside, crowded rivals to his inside causing them to steady and ran-on chasing the winner home. COACH PETRO slow early to be the distant trailer and rallied with a belated bid to gain a minor award. SAN MARCO CITY raced in mid-pack and showed some mild interest late. CHENTI raced in contention down the backside from the rail, steadied on the turn off heels and lacked a closing bid going evenly from there. SOUTHERN BREEZE sped to the lead into the first turn, opened a wide advantage down the backstretch and tired in upper stretch. OVERHAUL was well placed stalking the winner from afar down the backstretch, closed the gap into the far turn, was steadied when put in tight by rivals to his outside and never regained stride dropping to the rear of the field.
