PRICHARD set a well handled pace while inside, was challenged turning for home then was clearly best in the end. EGYPTIAN KING stalked the pace while two wide then made a bid in upper stretch but came up empty in late stretch. TIVERTON was unhurried early then raced two wide on the backstretch but failed to menace. CRIMINAL DEFENSE was unhurried early then avoided a rival on the backstretch and was no threat. MACLIN was two wide on the backstretch then stumbled badly and was pulled up then equine ambulance off the track.
