JURA set the pace racing with a clear lead, shook free on the far turn, responded when roused in the stretch, dug in gamely inside in the final sixteenth and held on late. CASANOVA KITTEN was bumped and steadied at the start, tracked on the inside, then two wide, came three wide into the lane, rallied outside in the stretch run, commenced a late bid and was closing the gap at the finish. KARMA DIRECTOR broke in bumping a rival at the start, raced off the pace inside, advanced inside on the backside, chased on the far turn and lacked a bid. PICKFORD raced three wide on the first turn, stalked outside, chased and gave way.
