## Footnotes | View Glossary Of Terms

VEE'S REASON raced near the back down the backstretch then made a five wide bid on the final turn, shifted back inside at the top of the stretch to make a rail run and drove past the leaders and won going away. GAMBI went to the lead from the inside down the backstretch then drew clear going into the final turn but was collared near the eighth pole and stayed on to hold the place. MALICE MAMA raced near the back around the first turn then steadily advanced through the final turn and made a late run to miss the place. DYNAMO'S CODE raced near the back down the backstretch then made a three wide bid on the final turn, tipping out to five wide in upper stretch but drifted out near the eighth pole cutting off rival and bumping with BETO'S BIRDIE, kept on for the

rally. LORIS STILL CURLIN pressed the pace from the inside around the first turn then settled off the pace through the final turn but lacked a late kick and was outfinished. BETO'S BIRDIE was unhurried down the backstretch while saving ground then moved up from two wide into the final turn, tipped out to five wide in upper stretch and was bumped near the eighth pole by DYNAMO'S CODE but kept on to improve position. RACHEL'S KID raced in the middle of the pack down the backstretch and faded. RAISON D'AMOUR was forwardly placed from two wide down the backstretch then saved ground around the final turn but lacked the late response. GIFTBOX SURPRISE raced in the middle of the pack, steadied near the eighth pole and lost action. I STAND COLLECTED rushed up to press the pace from three wide to the final turn and weakened. ELICIT raced in the middle of the pack down the backstretch then cropped back. This race was originally hand timed and was re-timed using video technology to arrive at the most accurate time. JOCKEY OBJECTION THE RIDER OF GIFTBOX SURPRISE CLAIMED FOUL AGAINST DYNAMO'S CODE FOR INTERFERENCE IN THE STRETCH, AFTER A STEWARDS REVIEW THE CLAIM OF FOUL WAS ALLOWED AND DYNAMO'S CODE WAS DISQUALIFIED FROM FOURTH TO NINTH.
