BASSCOAT saved ground while being reserved off the pace, slipped through entering the stretch, caught DONTMISSDAMINISTER nearing the eighth pole, dueled with that one to deep stretch and proved best under strong handling. DONTKISSDAMINISTER saved ground setting the pace, drifted out slightly nearing the quarter pole, responded when challenged by BASSCOAT and held on gamely during the drive. TAKE CHARGE D'ORO was allowed to settle racing three-wide, came four-wide into the stretch and finished well in a steady effort. CONTRABANDISTA was forwardly placed racing two-wide, came three-wide into the stretch and lacked a rally. MR. PETERKIN was unhurried early, came four-wide into the stretch but failed to seriously threaten. CRAFTED was rank to place early then raced in the back of the field, rallied five-wide into the stretch but failed to be a factor.
