TRUE JEDI was forwardly placed early, rallied four-wide into the stretch and was up in the final sixteenth to win going away. HIGH PROBABILITY vied for the early lead racing three-wide, took the lead entering the stretch then angled in nearing the eighth pole when clear but was unable to resist the winner late. ONE FOR MY BROTHER was allowed to settle, came three-wide into the stretch and rallied late. JEFE DE OBRA (CHI) prompted the early pace racing two-wide, was in tight nearing the three-eighths pole dropping back slightly then moved back up to dispute the issue into the stretch and weakened slightly late. PARTYVICIOUS was unhurried, swung out to be eight-wide entering the stretch and failed to seriously threaten. FOLLOW YOUR DREAM saved ground racing in the back on the field and was not a factor. BACKSTRETCH was close-up to near the stretch racing along the inside and tired. THE JOCKEY OF JEFE DE OBRA (CHI) LODGED AN OBJECTION AGAINST HIGH PROBABILITY FOR INTERFERENCE NEAR THE THREE-EIGHTHS POLE AND AROUND THE TURN BUT AFTER VIEWING THE FILMS THE STEWARDS MADE NO CAHNGED IN THE ORDER OF FINISH,
