## Footnotes | View Glossary Of Terms

WE'LL DO IT LIVE set the pace along the inner rail, drifted out in upper stretch and held sway under pressured. BEACH KITTEN bumped with MS THE LAW after bobbling at the break, raced four wide, chased the winner and gained late. CAMPAIGN PROMISES, five deep leaving the backstretch, circled foes on the turn and finished evenly. RETAIL THERAPY stayed in the two path on the turn, worked between horses in the stretch and passed tired ones. RYE SMILE prompted the winner and weakened. SAVE THE BEES, no factor, drifted very wide leaving the turn. MS. THE LAW, bumped at the start, chased the pace from the three path leaving the backstretch and gave way. MT. D'ORO stayed along the inner rail and weakened.
