CROCODILEHUNTER dueled two deep, cleared off into the far turn and held safe under strong handling. HAUNTED HAZE dueled near the inside and held the place position. TWOKO BAY dropped back to race mid pack, saved ground past the quarter pole and finished willingly to the wire. WAY UP NORTH lag early on and needed more. WYNN TRIP urged early, raced four wide through the far turn and faded. HEAVENLY DEACON head turned at the start, straightened, dwelt start, stewards reviewed start and deemed Heavenly Deacon had a fair start and no action taken.
