I C GOLD chased the pace from the inside and cleared off past the eighth pole under a steady hand ride. EXQUISITE CANDY hard sent to duel from the inside and held well to be second best. ZANZORA raced along the inside through the far turn, shifted out five deep through the drive and moved up mildly. RAETASTIC dueled two deep outside of foe and weakened. TACTICAL EXPRESS trailed early on, raced six wide into the upper stretch and lacked a bid.
