JENSCO pressed the leader from the three path, dueled nearing the lane, wrestled an advantage in upper stretch then drove clear with a sixteenth to go. OUR SHENANIGAN set the pace in the two path, dueled with an outer presser turning for home, fought on after getting headed in upper stretch but yielded at the sixteenth pole. TEARIN'UP MY HEART tracked along the inside, chased while moving out to the four path entering the lane. ANGEL BELLA broke slowly, trailed along the inside and failed to menace.
