ROCHESTER vied two wide, led in the three path entering the lane, drove clear and drew off. SCUFFLE vied for the lead inside of the eventual winner, yielded to that one in upper stretch then held place. STONE COUNTY stalked along the inside, shifted out to the three path and between horses in upper stretch, but lacked any gain and needed more to reel in place. SEQUOIA STARS broke a beat slow, saved ground well back then stayed on mildly to edge fourth late. SHARONS ANGELS settled two wide, stayed on mildly to vie for fourth entering the final sixteenth but missed to an inner foe at the wire. GENTLEMAN JIM broke a beat slow, pursued from midpack three wide, chased in the four to five path around the turn, fanned six wide entering the lane then lacked a rally while hanging on his left lead. IN RAINBOWS broke a step slow, chased from the three to four path around the turn, shifted to the five path entering the lane then yielded between horses. TIMS broke outwardly, stalked three wide, chased four wide in upper stretch then faded between horses. RUN LIKE FORREST trailed in the five path and got outrun.
