INVULNERABLE sped early on, showed the way along the inside into the turn, remained in hand as an outer foe applied pressure turning for home, moved out to the two path in upper stretch then held firm after flopping back to his left lead in the final sixteenth. EYE WITNESS stalked from the three two two path, inched into striking range on the leader turning for home, but hung on his left lead in upper stretch, drifted out to the four path while sustaining pursuit in midstretch, straightened and ran on while continuing on his left lead but was kept at bay. MISTER BANDERAS tracked two wide and between horses, chased along the inside around the turn, then lacked any gain yet managed show. SHAN chased along the inside, moved out to the three path entering the lane then offered an even kick. DERBY DATE broke a step slow, trailed in the three to four path into the turn, improved position fanning to the five path entering the lane but failed to menace. FURIOUS ANGER broke a step slow, pursued off of the pace in the three path then faded between horses entering the lane.
