RENDER JUDGMENT brushed with an inner foe soon after the start, pressed two wide, bid along with an outer rival turning for home, wrestled an advantage while dueling with the early pace-setter entering upper stretch, drove clear with a sixteenth to go then got collared by an outer bidder late yet held. PAGODE was brushed on both sides and subtly put to tight quarters between horses at the start, stalked three wide, bid around the far turn, but yielded entering the lane, kept on and re-rallied in the final furlong to offer a late re-bid but missed. CHILLAX set the pace along the inside, met a pair of outer challenges around the far turn, got headed by his most immediate counterpart while dueling into upper stretch, fought on through midstretch but yielded with a sixteenth to go. HOUSE UNITED came out and brushed a rival soon after the start, tracked along the inside, chased around the far turn, moved out to the five path in upper stretch and failed to factor.
