## Footnotes | View Glossary Of Terms

JERSEY PEARL set the pace along the inside, inched free in the two path in upper stretch and held sway. EASY RED stalked along the inside, dueled for place while pursuing the leader through the lane and prevailed. MARMALADE SKYE tracked two to three wide into the turn, ranged up entering the lane, dueled for place thereafter but was denied. LEGADEMA saved ground well back then moved up. FIBBER pressed two wide and faded between horses in upper stretch. LADY MOSCATO pursued from the two path, chased while moving out to the four path in upper stretch and lacked a bid. NON VIOLENCE was forced outwardly at the start, raced at the rear in the seven path, tucked down to the three path into the turn, shifted to the five path into the lane and failed to factor. TAPIT QUICK tracked four wide and gave way. PISTOL lacked speed five to four wide and between horses into the turn, but was done early. COPPER EM broke outwardly, raced well back in the six to five path and made little impact.
