## Footnotes | View Glossary Of Terms

GARDINER stalked four wide, bid three wide into the turn, led turning for home, met an outer challenge entering the lane, battled neck and neck while trading bumps with that one through the lane and narrowly held. MIRACLE WORKER tracked in the four path, ranged up to bid entering the lane, dueled with an inner rival while exchanging bumps and narrowly missed. ROWDY RIOT raced forwardly three wide and between horses, bid two wide and between rivals entering the turn, vied while headed turning for home then yielded to the top pair at the furlong grounds. MI DINERO raced forwardly two wide and between horses, checked subtly at the half mile pole, chased in the two path around the turn, moved out to the five path in upper stretch and ran on evenly to miss show. OH PLEASE raced off of the pace in the three to five path and failed to menace. HARD TO SAY broke outwardly, trailed in the three path then improved. WAKAN tracked along the inside, got shuffled back at the half mile pole then tired. GLACIAL POWER set the pace along the inside, got headed by a pair of outer bidders into the turn then faded turninig for home. THE RIDER OF MIRACLE WORKER CLAIMED FOUL AGAINST GARDINER ALLEGING INTERFERENCE IN THE STRETCH. FOLLOWING THE OBJECTION, AS WELL AS A STEWARDS' INQUIRY, NO CHANGE WAS MADE TO THE ORIGINAL ORDER OF FINISH
